

General Terms and Conditions for participating in diving performance

For all we booked diving services, the following shall apply to participate. For lump-sum payments are in addition to the traveling conditions of the operator in relation to the services offered there and GTC filed.

1. Booking of Dive Services / Conclusion

Maintaining the accounting records, confirms that we are subject to booking your diving ability and therefore have adopted the booking and reservation of diving services. After presenting the diving vouchers, we are committed to your booked performances, and make your contract offer accept, unless you complete the prerequisites, in particular your diving ability and therefore your safety, comply.

2. Payment Terms

Payment is made to the account specified in the biller (or its intermediary with the company responsible for processing) according to the following rules and dates:

25% deposit is due upon receipt within 5 working days,
100% in less than 30 days prior to the drawdown of benefits, payable immediately on receipt of invoice, payments generally 30 days prior to provision of services without further notice.

If the possibility of paying with credit card disclosure, you should at the time of booking to make use of them or we pay by direct debit and you provide your consent in writing or during your online reservation issued electronically have made the withdrawals from your account on the same dates.

3. Reimbursement payments already, we can not confirm your booking or you we offer has been submitted to spare you do not adopted, we will you may have already paid deposit amount refunded immediately.

4. Cancellation charges are already booked for diving services

You can always withdraw from the contract. We recommend the resignation in writing with your booking reference number to send to us. The decisive factor for the resignation, the resignation Eingangsdatum your explanation. We are entitled for diving reasonable compensation benefits following statements:

- Cancellation 60 days before use 25%
- Cancellation 59-30 days before use 75%
- Cancellation 1-29 days before use 100%
- No-show on the day of the agreed performance 100%

At the time of booking of flat performance, the fees charged by the tour operator that you specify in the General Conditions (General Conditions) to see.

5. Changes posted Diving Services

If you search for your reservation, for example, change benefits or personal reservations, we are entitled to a reasonable expense allowance in the amount of 25.00 euros for the changes to be calculated. You will receive the revised travel documents after your amendment no later than 2 days with a new calculation.

6. Benefits

The services offered and their scope is apparent from the extent described in the offer and the accounting records, which you're looking for an online booking via email prior to Anspruchnahme and upon appointment with us to present them. Further agreements in writing and confirmation by us or the agent / organizer.

7. Participation in diving

If you are already a diver, you need to spot a valid and internationally recognized diving license (certification) and submit your logbook. If you already have more than a year no longer have diving, or do not submit the logbook, we reserve the right to pay you a check-dive performed. According to this additional expense is as a taster or Discovery dive basis.

8. Medical certificate

On location is a valid medical certificate submitted by your diving ability is confirmed. These are as follows

Regulations:

not older than 2 year (s), if you are under 40 years old,

not older than 1 year (s), if you are 40 years or older.

(Based on the observations of the Society for diving and over-pressure medicine - GTÜM)

9. Diving and Health

The diving is a challenging activity with physical stress. If you already in advance disorders have had or still have, you may dive to not participate. Basically, always:

12 hours before the dive, neither alcohol or drugs have been used. 24 hours before a flight can not be dipped.

Diving is under medication in advance with the responsible doctor to clarify.

10. Confirmation of diving fitness

The participant stated through its online booking or notification that no health concerns regarding the participation in diving activities.

11. Kids Diving

We may be children with the permission of your parents diving for 8 years. Provided, however, is the individual on-site assessment by a certified instructor of your child according to its suitability checks. Any reasonable refusals are not beanstandungsfähig. It is the decision of the instructor.

12. Sonderbrevets / Special Dive Courses / diving tours

Sonderbrevets, special diving courses and dive tours are dependent on the number of participating persons and weather dependent. Any necessary changes will be communicated to you.

13. Exclusion from participation in diving performance

During the immersion programs is the instructions of the instructor and / or the supervisor to be obeyed. Breach the immediate exclusion can have no entitlement to a refund of the performance.

14. Terms of Payment / Cancellations / Changes

Payment is made to the account specified in the Rechnungssteller. Es apply specified payment, change and cancellation rules which guide you in your posting can see them and confirm them.

15. Reimbursement of benefits already paid Immersion

Diving services for safety reasons, such as weather, canceled or not can be carried out, may be used by us and are terminverträglich again be repeated. Will diving services for security reasons misplaced dates, the dates with the participants agreed on the spot.

16. Insurance

17. Obligation

18. Jurisdiction

In proceedings of the dive against the participating provider is the residence of the traveler is relevant, unless the appeal is against or persons shall, after conclusion of the contract domiciled or habitually resident abroad or whose residence or habitual residence at the time the suit is not known. 19. General

20. Final Determination
